

# Publication of the Shavington-cum-Gresty Neighbourhood Plan

(Pre-Submission Version)

## The Neighbourhood Planning (General) Regulations 2012 (Regulation 14)

Dear Consultee

Shavington-cum-Gresty Parish Council, as the qualifying body, has prepared a Neighbourhood Plan (the Draft Plan) for the period 2018-2030 for the parish of Shavington-cum-Gresty which comprises the Village Ward and the Gresty Brook Ward.

This Draft Plan has been prepared by the Neighbourhood Plan Steering Group made up of parish councillors and residents from the parish. It has been informed by questionnaire surveys completed by local residents and businesses in 2017 and informal public consultation on the emerging Draft Plan.

**The consultation period runs for six weeks from 23 April 2019 to 5.00 pm on 5 June 2019.**

### Purpose of the consultation

The purpose of this consultation is to seek representations from statutory consultees and others whose interests may be affected by the draft proposals made.

Following this public consultation process, the Draft Plan will be amended and submitted to Cheshire East Council as the Local Planning Authority, together with all supporting documentation including a Basic Conditions Statement and Consultation Statement setting out who has been consulted, how the consultation was undertaken and how the representations have informed the Draft Plan.

Cheshire East Council will then re-consult before the Draft Plan is subjected to examination by an Independent Examiner.

Once any further amendments are made, the Draft Plan will be subject to a local Referendum and if more than 50% of those voting are in favour, it will be adopted by Cheshire East Council and will be used to determine planning applications in the parish.


